

SANTA YNEZ COMMUNITY SERVICES DISTRICT BOARD OF DIRECTORS - SPECIAL MEETING

Minutes of October 26, 2022

NOTE: This meeting was held in person and via teleconference, according to AB 361

1. CALL TO ORDER/FLAG SALUTE/ROLL CALL:

President Jones called the meeting to order at 5:02 PM, and Secretary Berry called the role. Directors Present: Jones, Padelford, Redfern, Beard, Van Pelt. Staff Present: General Manager Loch Dreizler, Wendy Berry, Secretary/Treasurer

- **2. DIRECTORS COMMENTS:** Director Van Pelt and Director Redfern met with a Chumash representative and the County Supervisor representative to discuss the future of Santa Ynez Park.

5. A. Draft Municipal Service Review (MSR) from LAFCO: LAFCO distributed the MSR survey to the District. Staff compiled the MSR survey data for Board review on April 20, 2022. LAFCO then prepared the draft MSR, and the Board of Directors reviewed it at the October 26, 2022, special meeting. Janin Acres is currently within the City of Solvang's sphere of influence and is designated as a special problem area. The draft LAFCO Staff Recommendation is that the SOI should include Study Area Three – Janin Acres. In addition, the lighting power of the District will be considered under a different MSR and evaluated by LAFCO with other agencies with lighting powers. The board consensus was to have staff make language changes and corrections and submit the revised draft to LAFCO with the understanding the draft would come back for further public and board review.
