Review, Discussion, and Recommendation on Awarding Contract for Horizon

Drive Mainline Extension Project

#### Recommendation

Review, discuss, and provide staff with direction on awarding contract to complete Horizon Drive mainline extension project and authorizing the General Manager or Board Secretary to sign the contract agreement on behalf of the District and authorize the General Manager to sign the notice to proceed and notice of award.

#### **Policy Implications**

The District solicited bids for the Horizon Drive mainline extension project. Three bids were received for the project, one bid being disqualified as it arrived late, but submitted for reference.

## Fiscal Implications

The bids received to complete the project came in between the range of \$998,315-\$1,273,170. The total costs to complete the project could be realized within the range of \$1,200,00-\$1,473,000. This figure would consider the costs for construction management services, soils compaction testing and inspection work, and all additional work completed prior to project commencement.

#### **Alternatives Considered**

The alternatives the Board could consider would be to reevaluate the project and resolicit bids incorporating a larger portion of the westside area, resolicit bids solely with Horizon Drive, or reject all bids and reevaluate the project.

#### **Discussion**

The Horizon Drive mainline extension project is a vital undertaking, aimed at ensuring the residents within the project area can make the transition from septic to sewer, as needed and required. The project is also beneficial and imperative in ensuring the future conversion of the Santa Ynez westside corridor from septic to sewer.

The replacement of on-site septic systems and converting to sewer services was recommended in the Onsite Wastewater Treatment Systems Local Agency Management Plan (LAMP), published by the Santa Barbara County Public Health Department - Environmental Health Services. The LAMP recommended the conversion from septic systems to public sewers in several areas of Santa Barbara County including portions of the west side of Santa Ynez, where significant

problems or threats to public health have been identified. This project will be the first step in providing twenty-one parcels along Horizon Drive the option to abandon their septic systems and connect to the public sewer system.

The proposed project will extend the sewer pipeline collection system with a connection at an existing District manhole along Highway 246, just south of Horizon Drive. The project will continue north from this manhole through three acquired property easements up to Horizon Drive. The mainline will continue east and west along Horizon Drive, terminating at the east end of the road and at the west end prior to reaching Refugio Road. The mainline extension will allow for twenty-one parcels to connect to the sewer system and for future expansion of the District collection system.

The District has invested in this project to date with the engineering plans, specifications and designs completed by the District engineer, the consulting services provided by Hamner, Jewell and Associates in procuring the required easements, a biological survey completed by Terra Verde Environmental Consulting, legal services to review and assist in compilation of all legal documents and agreements, consulting work completed by Tuckfield and Associates with completion of the capacity fee study, and District staff time and efforts coordinating all these services throughout the process. Staff ensured that the Board and public were provided with regular updates to allow the Board to provide the necessary direction to proceed with the project.

At its March 10, 2021 Special Board meeting, the Board reviewed, discussed, and authorized staff to issue and release an invitation to bid, along with all bidding documents. On March 17, 2021, these documents were released, advertised in several newspapers, and posted on the District's website for prospective contractors to review and consider the project.

Within the bid documents, staff provided a date for a mandatory pre-bid meeting and site walk. District staff maintained communication with all prospective contractors and responded to all inquiries from contractors, issuing two addenda. These addendas contained all responses to inquiries from the contractors who attended the pre-bid meeting and were planning to submit bid packets.

On Tuesday May 11, 2021 at 2:00pm, with two contractors delivering their bids, staff opened the bid packets for public presentation. The bids were documented, and amounts compiled on a spreadsheet to send out to staff and contractors. A third bid was received by the District, but the bid is disqualified as it arrived late and not by the required bid opening time. This third bid is included for reference only.

The three bids submitted are as follows:

- Specialty Construction Inc.- \$998,315
- Tierra Contracting-\$1,126,600
- Raminha (Disqualified)- \$1,273,170

Attached for the Board to review are the public bid opening compilation listing and the three bid packets submitted. The two bids that may be considered were submitted by Specialty Construction Inc. and Tierra Contracting. Also attached, if the Board chooses to proceed with awarding the contract, are the Notice of Award, Notice to Proceed, and Agreement documents, which were included in the final bid documents.

Staff is requesting the Board to review, discuss, and provide direction to staff on how to proceed with the project. Staff is also requesting the Board to authorize the General Manager or Board Secretary to sign the project documents on behalf of the District.


