Adopt Resolution No. 26-07D removing Loch Dreizler as the District Treasurer and appointing Alexandra Griffith as District Treasurer.

According to Government Code § 61050(c), the Board of Directors may appoint the same individual to serve as both the General Manager and District Treasurer.

Discussion:

Adoption of Resolution No. 26-07D is necessary to ensure continuity of District operations following the transition in General Manager leadership. The resolution removes Loch Dreizler as District Treasurer and appoints Alexandra Griffith, General Manager, to serve in that capacity.

As District Treasurer, Ms. Griffith will perform duties required by law and District policy, including providing financial reports to the Board of Directors on a quarterly basis, or more frequently as directed by the Board, regarding District receipts, disbursements, and account balances. The Treasurer will also execute documents and other instruments requiring the Treasurer's signature.

WHEREAS, Loch Dreizler retired from employment with the Santa Ynez Community Services District effective July 3, 2026; and

WHEREAS, the Board of Directors finds it necessary and in the best interest of the District to appoint a District Treasurer to ensure the continued administration of District financial affairs.

1. Loch Dreizler is hereby removed from the position of District Treasurer effective July 15, 2026.
2. Alexandra Griffith, General Manager, is hereby appointed District Treasurer effective July 15, 2026.
3. As District Treasurer, Alexandra Griffith shall perform all duties required by applicable law, District policies, and Board direction.
