**SUBJECT:** Ordinance O-21-04, an Ordinance of the Santa Ynez Community Services District revising existing capacity fee ordinances, approving new capacity fees for Highway 246 Undercrossing and Horizon Drive Projects, and amending sewer service code.

#### Recommendation

Adopt Ordinance O-21-04, an Ordinance of the Santa Ynez Community Services District revising existing capacity fee ordinances, approving new capacity fees for Highway 246 Undercrossing and Horizon Drive Projects, and amending sewer service code.

#### **Policy Implications**

The District adopted the Sewer Service code by Ordinance O-98-04 which states the District will charge a capacity fee at the time the parcel connects to the District's sewer system. The District's current capacity fee for a single-family dwelling is \$6336.98 per Equivalent Residential Unit (ERU) and will increase to \$9995.96 May 1, 2022. The Highway 246 Undercrossing cost \$135,996.00 and Horizon Drive cost \$1,332,254.00, will also be included in this ordinance. The Ordinance will be available for future reference and guidance in assessing fees for these items.

#### Background

At the August 18, 2021, regular board meeting, the Board approved Ordinance O-21-03 approving the increase in capacity fees. The State has changed the requirements for Additional Dwelling Units (ADU's), Ordinance O-21-04 will be amended to reflect those changes.

To make sewer available to certain parcels within the western portions of the District's territory, the District constructed the Highway 246 Undercrossing in 2016. Once the Highway 246 undercrossing was completed the District was able to move forward with the Horizon Drive project. This undercrossing will allow for 208 parcels to connect to the district sewer system in the future; thus the cost of the project must be divided amongst all benefited parcels. The Horizon Drive Project was completed October 22, 2021, and approved by the Board at the November 17, 2021.

At the December 8, 2021, special meeting the Board accepted the final cost study prepared by Tuckfield and Associates. A public hearing will be held tonight regarding the new capacity fees, allowing for any comments or concerns to be presented.

#### **Discussion**

The District desires to (i) clarify certain provisions that apply to the Basic Capacity Fees, and (ii) address the amendments to Government Code Section 65852.2 that were made by Assembly Bill 3182 as they apply to the ADU Capacity Fees, as more particularly set forth on Exhibit "A-1" attached hereto.

The District has identified 208 parcels that may connect to and benefit from the Highway 246 Undercrossing in the future. Those parcels are located within the area identified on the map and are listed on the table attached hereto as Exhibit "A-2". To equitably allocate the cost of the Highway 246 Undercrossing among those parcels, the District has determined that each such parcel should pay a special capacity fee in the amount of \$654 (\$135,996/208 = \$654) (the "Highway 246 Capacity Fee").

The cost of the Horizon Extension was \$1,332,254.00. The District has identified twenty-three parcels that may connect to and benefit from the Horizon Extension in the future. Those parcels are located within the area identified on the map and are listed on the table attached hereto as Exhibit "A-3". To equitably allocate the cost of the Horizon Extension among those parcels, the District has determined that each such parcel should pay a special capacity fee in the amount of \$57,924.00 (\$1,332,254.00/23 = \$57,924.00) (the "Horizon Capacity Fee"). The total fees paid by Horizon Drive Residents includes district capacity fees, annexation fees, and the Highway 246 undercrossing fees, with the total, if paid in cash, to \$67,195. The total costs could inflate, if the customer decides to enter into an installment payment plan with the district or elects to hold off on pay the fees for connection.

#### ORDINANCE NO. O-21-04

#### AN ORDINANCE OF THE SANTA YNEZ COMMUNITY SERVICES DISTRICT REVISING EXISTING CAPACITY FEE ORDINANCES, APPROVING NEW CAPACITY FEES FOR HIGHWAY 246 AND HORIZON DRIVE PROJECTS, AND AMENDING SEWER SERVICE CODE

WHEREAS, the Santa Ynez Community Services District (the "District") has adopted a Sewer Service Code pursuant to Ordinance No. O-98-04 (the "Sewer Service Code").

WHEREAS, pursuant to Section 807 of the Sewer Service Code, the District charges District-wide basic capacity fees for all parcels that connect to the District's sewer system (the "Basic Capacity Fees"). The District's current Basic Capacity Fees were approved by Ordinance No. O-21-03 on August 18, 2021, which amended Exhibit "A" to the Sewer Service Code.

WHEREAS, pursuant to Section 807 of the Sewer Service Code, the District also charges District-wide capacity fees for certain accessory dwelling units that connect to the District's sewer system (the "ADU Capacity Fees"). The District's current ADU Capacity Fees were by approved by Ordinance No. O-17-03 on December 20, 2017, which amended Exhibit "A" to the Sewer Service Code.

WHEREAS, the current ADU Capacity Fees were calculated in accordance with Government Code Section 65852.2, as amended by Senate Bill 229, effective as of January 1, 2018. Government Code Section 65852.2 was subsequently amended by Assembly Bill 3182, effective as of January 1, 2021.

WHEREAS, The District desires to (i) clarify certain provisions that apply to the Basic Capacity Fees, and (ii) address the amendments to Government Code Section 65852.2 that were made by Assembly Bill 3182 as they apply to the ADU Capacity Fees, as more particularly set forth on Exhibit "A-1" attached hereto.

WHEREAS, Section 807(B)(iii) of the District's Sewer Service Code provides that the District may establish special capacity fees for any sewer connection when, in the opinion of the District's Board of Directors, the circumstances of a connection necessitate the payment of charges over and above the District's Basic Capacity Fee in order to establish conditions of equality between those who have borne the cost of the existing District sewage system and those who own any parcel, unit, lot, or portion thereof, benefiting from, but not participating in, the cost of such facilities.

WHEREAS, in order to make sewer service available to certain parcels of property located within the western portions of the District's territory, the District has constructed an extension to the District's wastewater collection system consisting of a 10" sewer line installed under Highway 246 (the "Highway 246 Undercrossing"). The Highway 246 Undercrossing is more particularly described in the contract documents dated September 25, 2016 prepared by the District's engineer, Cannon Associates.

WHEREAS, the cost of the Highway 246 Undercrossing was \$135,996.00. The District has identified 208 parcels that may connect to and benefit from the Highway 246 Undercrossing in the future. Those parcels are located within the area identified on the map and are listed on the table attached hereto as Exhibit "A-2". To equitably allocate the cost of the Highway 246 Undercrossing among those parcels, the District has determined that each such parcel should pay a special capacity fee in the amount of \$654 (\$135,996/208 = \$654) (the "Highway 246 Capacity Fee").

WHEREAS, in order to make sewer service available to certain parcels of property located in the vicinity of Horizon Drive, the District has constructed an extension to the District's wastewater collection system consisting of (i) 1,905 linear feet of 8" PVC gravity sewer main line located in Horizon Drive and in easements on private property connecting to the District's sewer main line in Highway 246, (ii) wyes to accommodate the connection of private laterals, and (iii) 6 manholes with hinged lids (the "Horizon Extension"). The Horizon Extension is more particularly described in the contract documents dated March 17, 2021 prepared by the District's engineer, Cannon Associates.

WHEREAS, the cost of the Horizon Extension was \$1,332,254.00. The District has identified 23 parcels that may connect to and benefit from the Horizon Extension in the future. Those parcels are located within the area identified on the map and are listed on the table attached hereto as Exhibit "A-3". To equitably allocate the cost of the Horizon Extension among those parcels, the District has determined that each such parcel should pay a special capacity fee in the amount of \$57,924.00 (\$1,332,254.00/23 = \$57,924.00) (the "Horizon Capacity Fee").

**NOW, THEREFORE**, the Board of Directors of the Santa Ynez Community Services District ordains as follows:

- 1. <u>Amendments to Existing Capacity Fee Ordinances</u>. In order to (i) clarify certain provisions that apply to the Basic Capacity Fees, and (ii) address the amendments to Government Code Section 65852.2 that were made by Assembly Bill 3182 as they apply to the ADU Capacity Fees, the Board hereby approves Exhibit "A-1" attached hereto.
- 2. Approval of Highway 246 Capacity Fee. The Board hereby approves the Highway 246 Capacity Fee in the amount of \$654. The Highway 246 Capacity Fee shall apply to (i) each of the parcels identified on Exhibit "A-2" attached hereto, and (ii) each parcel created by the subdivision of any of said parcels. The Highway 246 Capacity Fee shall be in addition to (as applicable) the Basic Capacity Fees, ADU Capacity Fees, Horizon Capacity Fee, special capacity fees relating to Project 1 and Project 2, sewer service charges, sewer benefit fees, inspection fees, plan check fees, annexation fees, and annexation administrative charges.
- Approval of Horizon Capacity Fee. The Board hereby approves the Horizon Capacity Fee in the amount of \$57,924.00. The Horizon Capacity Fee shall apply to (i) each of the parcels identified on Exhibit "A-3" attached hereto, and (ii) each parcel created by the subdivision of any of the parcels identified on Exhibit "A-3". The Horizon Capacity Fee shall be in addition to (as applicable) the Basic Capacity Fees, ADU Capacity Fees, Highway 246 Capacity Fee, sewer service charges, sewer benefit fees, inspection fees, plan check fees, annexation fees, and annexation administrative charges.

- 4. Adjustments to Basic Capacity Fees. The Basic Capacity Fees shall be adjusted effective as of the first day of January of each year, commencing January 1, 2023, by an amount equal to the percentage change in the Engineering News Record Construction Cost Index National Average published for the immediately preceding October as compared to such index for October of the previous year.
- 5. Adjustments to ADU Capacity Fees. Because the ADU Capacity Fees are calculated as a percentage of the Basic Capacity Fees, the ADU Capacity Fees will automatically adjust when annual adjustments are made to the Basic Capacity Fees as set forth in Section 4, above.
- 6. Adjustments to Highway 246 Capacity Fee. The Highway 246 Capacity Fee shall be adjusted effective as of the first day of January of each year, commencing January 1, 2023, by an amount equal to the percentage change in the Engineering News Record Construction Cost Index National Average published for the immediately preceding October as compared to such index for October of the previous year.
- 7. Adjustments to Horizon Capacity Fee. The Horizon Capacity Fee shall be increased effective as of the first day of January of each year, commencing January 1, 2023, by three percent (3%).
- **8.** <u>Amendments to Sewer Service Code.</u> The Sewer Service Code, as previously amended, is hereby further amended as follows:
- a. The last sentence of Section 807(A) is deleted in its entirety and is replaced with the following:
  - "A schedule of the basic capacity fees is set forth in Exhibit "A-1"."
- **b.** Exhibit "A" is deleted in its entirety and is replaced with Exhibit "A-1" attached hereto to set forth the Basic Capacity Fees and the ADU Capacity Fees.
- **c.** Section 807(B)(iii) is amended to add the following sentence to the end thereof:
  - "Special capacity fees relating to the District's Highway 246 undercrossing project and the District's Horizon Drive main line extension project are set forth in Exhibits "A-2" and "A-3" attached hereto."
- **d.** Exhibits "A-2" and "A-3" attached hereto are hereby added to set forth the Highway 246 Capacity Fee and Horizon Capacity Fee.
- 9. Findings. The Board hereby finds that, (i) in compliance with Article XIIIA, Section 4 of the California Constitution and Section 50076 of the Government Code, the capacity fees set forth in this Ordinance do not constitute a special tax requiring voter approval, (ii) based on the capacity fee studies undertaken by the District, the cost of the Highway 246 Undercrossing, the cost of the Horizon Drive Project, the approved budget, and revenue and cost projections of the District, the revenues forecast to be generated by the

capacity fees do not exceed the estimated reasonable cost of providing sewer service to the customers of the District and to the users within each of the classes established in Exhibits "A-1", "A-2", and "A-3", (iii) the revenues derived from the capacity fees will not be used for any purpose other than that for which the capacity fees are imposed, (iv) the amount of the capacity fees will not exceed the proportional cost of the service provided to any parcel, and (v) the capacity fees will be imposed only where service is actually used by, or immediately available to, the owner of the property in question.

- 10. <u>Effective Dates</u>. This Ordinance shall be effective thirty (30) days following the date of publication; provided, however, that the Basic Capacity Fees set forth in Exhibit "A-1" shall be effective as of May 1, 2022.
- 11. <u>Continued Effect</u>. Except as specifically amended herein, all of the terms and provisions of the Sewer Service Code, as previously amended, shall continue in full force and effect. This Ordinance shall supersede and replace Ordinance No. O-21-03 and Ordinance No. O-17-03 to the extent that the terms and provisions of those earlier Ordinances conflict with the terms and provisions of this Ordinance.

#### **EXHIBIT "A-1"**

#### **Basic Capacity Fees and ADU Capacity Fees**

The Basic Capacity Fees and the ADU Capacity Fees shall be in the amounts shown on the table included under this Exhibit "A-1" (the "Capacity Fee Table"). The terms and provisions set forth below shall apply to Capacity Fee Table.

#### **CAPACITY FEE ADJUSTMENTS**

Per Note [1] on the Capacity Fee Table, the Basic Capacity Fees shall be adjusted effective as of the first day of January of each year, commencing January 1, 2023, by an amount equal to the percentage change in the Engineering News Record Construction Cost Index National Average published for the immediately preceding October as compared to such index for October of the previous year.

#### **DEFINITIONS**

**ADU:** An accessory dwelling unit as defined in Government Code Section 65852.2, as said code section may be amended from time to time in the future.

**DFUs:** The number of drainage fixture units for each type of appliance, appurtenance or fixture, as set forth in the then current California Plumbing Code.

Base Charge: The then current Basic Capacity Fee for a single-family dwelling.

**Strength Factor:** The strength factor of wastewater, as defined under Section 820(C) and as determined under Section 821 of the District's Sewer Service Code.

**Unclassified User:** Any user group or classification not shown in the Capacity Fee Table.

#### **CAPACITY FEE FOR UNCLASSIFIED USERS**

For any Unclassified User, the Basic Capacity Fee for the first 20 DFUs shall be calculated as follows:

Capacity Fee = Base Charge x Strength Factor

#### ADDITIONAL FIXTURE CHARGE

An additional fixture charge shall be applicable to (i) any user group or classification shown in the Capacity Fee Table for which the capacity fee relates to the first 20 DFUs, and (ii) any Unclassified User which has more than 20 DFUs. Said additional fixture charge shall be calculated as follows:

Additional Fixture Charge = (Number of DFUs in excess of  $20 \div 20$ ) x Base Charge x Strength Factor

#### **ADU CAPACITY FEES**

Per Note [2] on the Capacity Fee Table, the ADU Capacity Fee for the first 15 DFUs shall be calculated as follows:

Capacity Fee = Base Charge x.74

#### **ADDITIONAL FIXTURE CHARGE FOR ADUS**

An additional fixture charge shall be applicable to any ADU which has more than 15 DFUs, calculated as follows:

Additional Fixture Charge = (Number of DFUs in excess of  $15 \div 20$ ) x Base Charge x Strength Factor

#### **LIMITATIONS ON ADU CAPACITY FEES**

The ADU Capacity Fees shall only apply in cases where the District is permitted to charge a connection fee or capacity charge under Government Code Section 65852.2, as said code section may be amended from time to time in the future. As of the date of this Ordinance, Government Code Section 65852.2 permits the District to impose a connection fee or capacity charge where an ADU (i) is not within the existing space of a single-family dwelling or accessory structure, or (ii) is constructed with a new single-family residence.

#### YMCA CAPACITY FEE

Per Note [3] on the Capacity Fee Table, the YMCA has a payment agreement with the District based on annual flow.


